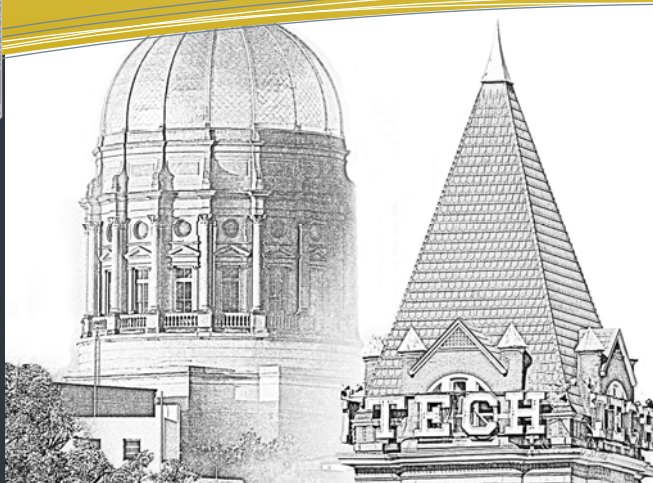

Chancellor Presents Budget Request to Legislators

University System Chancellor Erroll B. Davis, Jr. had the opportunity over the last two weeks to formally speak before the Joint Committee on Appropriations and the House Higher Education Appropriations Subcommittee about the University System budget for FY 2009 and FY 2010.

During both visits he asked lawmakers to think of the University System as "an investment, not a cost" and as "a solution, not a problem." He underscored that the main challenge facing the University System is how to maintain quality with diminished resources and additional students.

During his presentation before the joint committee, Chancellor Davis conveyed his gratitude for Governor Sonny Perdue's recommendations of incremental formula

funding in the amount of \$109 million, capital bond funding of \$325.2 million, which includes \$70 million in Major Repair and Rehabilitation funding, and \$43 million for construction of the Clough Undergraduate Learning Commons. However, he expressed concerns about the 10.5 percent cut to the System's base budget, which totals \$243 million. From that amount, more than \$197 million affects the teaching mission of the state's colleges and universities. He used the proposed \$1 million reduction to the Georgia Tech Regional Engineering Program (GTREP) as an example of a reduction that could impact the state's future by not supplying needed engineers to South Georgia.

Legislators questioned Chancellor Davis about many topics but

were particularly interested in the potential of University System mandatory employee furloughs. The Chancellor stated that he is "philosophically opposed to furloughs" because he believes they postpone problems rather than solve them.

These presentations by the Chancellor and other agency heads indicate that the budget process is moving forward. The subcommittees of the House Appropriations Committees are considering the FY 2009 amended budget now and will send reports to the full committee after the hearings have concluded. Once the amended budget is sent to the Senate for action, then the House will begin work on the FY 2010 general budget. ■

Tech Student Shines at Subcommittee Meeting

Higher Education Appropriations Subcommittee Chairman Bob Smith (R-Watkinsville) recently invited representatives from Georgia Tech, Georgia State University and the University of Georgia to speak to his subcommittee about entrepreneurship.

Dr. Marie Thursby, management professor and founder of the

Technological Innovation: Generating Economic Results (TI:GER®) program and one of her students, Mr. Walter Voit, spoke to the committee about the benefits of this unique program. TI:GER® pairs a Ph.D. student with MBA and law students (from Emory University) to take an idea from the lab to the marketplace.

Voit is working toward a doctorate in Materials Science and Engineering and has developed a polymer that can be used for custom-fitting ear devices. He enthusiastically told the subcommittee about his team's work to commercialize this product and what a positive experience he has had with the TI:GER® program. Legis-

Georgia Tech Head Football Coach Paul Johnson and sophomore running back Jonathan Dwyer can add General Assembly commendations to their already impressive list of recognitions for the 2008 football season. Last Wednesday, both the House and Senate rose in standing ovations for the coach and player.

SR 32 recognized Coach Johnson for being named ACC Coach of the Year and SR 33 recognized Jonathan Dwyer for his selection as ACC Player of the Year.

Senate Majority Leader Chip Rogers, MGT 1991, spoke to the resolutions and wel-

comed them to the Senate chamber. He spoke of the excitement and honor they had brought to Georgia Tech and hailed Jonathan Dwyer as a true representative of what scholar-athletes are all about.

In the House, Majority Leader Jerry Keen spoke to House Resolutions 117 and 118 and the season's highlights including wins over Miami, Florida State University and the University of Georgia (to the playful moans of some of the Bulldog faithful).

Coach Johnson and Jonathan briefly spoke in both chambers where they said that they see a bright future at Georgia Tech

where they hope to win an ACC Championship and a national championship.

Another recognizable face at the Capitol last week was former Georgia Tech basketball player Matt Causey. Matt has begun a career at Merrill Lynch in Atlanta. He stayed at the Capitol for several hours with Tech officials speaking to legislators and thanking them for their support of his alma mater.

These three men are great representatives of the Institute. **T**

GTRI, Tech Standouts Recognized at Capitol

The Georgia Tech Research Institute was commended in the Senate last week (SR 51) in celebration of its 75th anniversary.

GTRI was created by the General Assembly in 1934 as the State Engineering Experiment Station. Today, GTRI performs more than \$185 million annually in research and development with more than 1,300 employees.

The resolution commended GTRI employees for their dedication and the significant contributions made to Georgia through its 75 years of existence. The resolution was sponsored by Georgia Tech alumni Sens. Chip Rogers and Johnny Grant.

Rep. Hardie Davis, also a GT alum, will sponsor a similar resolution in the House.

Resolutions mirroring those adopted in the House of Representatives two weeks ago were also adopted in the Senate last week commending Professor Mostafa El-Sayed, tennis champion Amanda McDowell, and the 100th anniversary of the Tech Band. **T**

United States of America by developing, and expanding education for the support of science, innovation, technology, energy, and new Georgia entrepreneurs."

He is also sponsoring HR 166 which would establish the Joint House and Senate SITE (Science, Innovation, Technology and Energy) TO GROW GEORGIA, Alternative

Financing, and Entrepreneurship Study Committee. This study committee would be charged with studying the state laws, conditions, needs and issues concerning entrepreneurship and make recommendations to enable Georgia to become the premier destination for entrepreneurs. **T**

Last week, we profiled Senate Majority Leader Chip Rogers (R-Woodstock), MGT 1991. Joining him in the Senate is Johnny Grant (R-Milledgeville), IE 1972, who represents the 25th Senate District in central Georgia.

Sen. Grant was first elected to the Senate in 2004. He is chairman of the State Institutions and Property Committee, vice chair of the State and Local Governmental Operations Committee and is a member of the Health and Human Services, Governmental Oversight, Public Safety and Appropriations committees.

Rep. Hardie Davis (D-Gracewood), EE 1992, is beginning his second term in the House of Representatives where he was elected by his caucus to serve as Assistant Whip.
